### YRC Worldwide Provides Quarter-To-Date Operating Data for Fourth Quarter 2018

OVERLAND PARK, Kan., December 10, 2018 — YRC Worldwide Inc. (NASDAQ: YRCW) reported certain operating metrics for the first two months of fourth quarter 2018.

At YRC Freight, October 2018 tonnage per day decreased approximately 7.1% compared to October 2017 and November 2018 tonnage per day decreased approximately 1.4% compared to November 2017. Quarter-to-date through November 2018, revenue per hundredweight increased approximately 8.8% compared to a year ago. Revenue per shipment increased approximately 5.3% quarter-to-date through November 2018, compared to the same period last year.

At the Regional segment, October 2018 tonnage per day decreased approximately 5.5% compared to October 2017 and November 2018 tonnage per day decreased approximately 6.5% compared to November 2017. Quarter-to-date through November 2018, revenue per hundredweight increased approximately 8.6% compared to a year ago. Revenue per shipment increased approximately 8.7% quarter-to-date through November 2018, compared to the same period last year.
